WHEREAS, the BCPC formulated a plan that contains programs, projects and activities that will address child's right to survival, protection, development and participation of children.

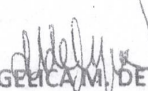
WHEREAS, BCPC Plan required fund allocation for the major implementation.
